


Vision and Values

We know that a life free from violence is possible. We are committed to catalysing the change necessary to achieve that.

Full Stop Australia is a secular, feminist, not-for-profit organisation in its 50th year of operations. We have a rich legacy of supporting people of all genders who have experienced sexual, domestic and family violence. We foreground people with lived experience in every aspect of our work, listening to their needs, amplifying their voices and supporting those wishing to contribute directly to the public conversation. Everything we do is informed by the insights and perspectives of the people we support.

Organisational Strategy 2022-2025

We know that providing one-off services is not enough. That's why we start with the end in mind, using a social impact framework to guide our strategy. Our approach integrates intersectional feminism, cultural safety, traumainformed practice and social justice into our work across the areas of clinical service delivery, education and change making.



We believe in:

- courage—speaking up, shining a light on inequity and taking risks to dismantle the conditions that lead to violence
- inclusion and diversity—supporting communities where everyone belonas
- integrity and accountability—we are consistent, reliable and ethical in all we do.

Our purpose is to put a full stop to sexual, domestic and family violence.

Our objectives are:

- b to provide excellence in traumaspecialist support services for people directly and indirectly impacted by sexual, domestic or family violence
- to **educate**, train, support and resource governments, businesses, not-for-profits, and community organisations to effectively prevent and respond to sexual, domestic and family violence
- to drive changes to the systems and structures that create the conditions that allow sexual, domestic and family violence to be perpetrated and improve systems and responses.

How We Work

Providing high-quality counselling to victim-survivors:

Our trauma-specialist counsellors are only a phone call away 24 hours a day, 365 days a year. We meet people where they are, supporting their immediate needs with a view to long-term healing and recovery.

Supporting those at risk of vicarious trauma:

We support professionals and first responders with supervision, debriefina and self-care planning, thus contributing to the sustainability of services for victimsurvivors.

In 2023/24 we delivered almost 500 debriefing sessions and 54 sessions of clinical supervision and vicarious trauma-focused sessions, supporting professionals to manage the cumulative impacts of bearing witness to the aftermath of violence and abuse.

Developing and delivering tailored training progams:

Our training programs reach thousands of people every year, contributing to safety, respect and the prevention of violence in our communities.

In 2023/24 we piloted Anchored in Consent, a NSW Health funded train-thetrainer program for professionals working with young people at risk of problematic and harmful sexual behaviours.

Empowering workplaces to prevent and address violence:

We offer a suite of workplace programs and consulting services that support leaders and teams across all sectors to understand and dismantle the dynamics that contribute to gendered violence.

In 2023/24 we delivered a new program Empowering Safe Institutions so leaders can be on the front foot with positive duty obligations and set a positive example from the top down.

Amplifying lived-experience voices:

The needs, insights and perspectives of people with lived experience of violence inform everything we do. Our National Survivor Advocate Program (NSAP) and Advisory Group empower survivoradvocates to contribute to positive change.

Delivering high-quality advocacy:

To increase the safety, support, autonomy and choice for victim-survivors and ultimately put a full stop to sexual, domestic and family violence, we make submissions to government; contribute to inquiries, roundtables and working groups; meet with decision makers; and raise awareness through media and outreach.


Established in 2018 with consultation and training provided by ACON, the Rainbow Helpine is a national, 24/7 trauma specialist service that provides a 'front door' for anyone in LGBTQ+ communities impacted by sexual, domestic and family violence. Rainbow Helpline is a telephone and online service that complements community and peer-based services to offer direct access to trauma-specialist counsellors. The Rainbow Helpline provides crucial support to family and community members and delivers critical incident debriefing and vicarious trauma management to health and community services professionals.

The NSW Sexual Violence Helpline is in its 50th year in 2024. Established in NSW in October 1974, it was the first funded rape crisis service in Australia and has operated continuously since then. Funded by NSW Health, today the NSW Sexual Violence Helpline provides expert support for individuals impacted by sexual violence anywhere in NSW, from crisis intervention to medium and long-term recovery and healing. Closely linked with key government agencies and non government supports, the service continues to be critical infrastructure in NSW's response to sexual violence.

Over 10% of calls to our NSW Sexual Violence Helpline were from family members or friends.



Full Stop Australia is a registered provider for the National Redress Scheme. We offer a range of services to support people to engage with the scheme and apply for redress.

Our National Sexual Abuse and Redress Support Service is available 24/7 and demand for the service continues to grow.

The National Sexual Abuse and Redress Support Service

sexual abuse to access the National Redress Scheme.

The National Redress Scheme was established in response to the Royal Commission into Institutional Responses to Child Sexual Abuse, acknowledging the lifelong impacts of abuse in institutional settings. Full Stop Australia is a registered provider of the National Redress Scheme. This service provides 24/7 counselling, focusing on brief, targeted support that helps people manage the impact of trauma.

- We offer up to six sessions of appointment based counselling focusing on stabilising and building readiness to engage with the National Redress Scheme, and provide case management for people making an application.
- We received overwhelmingly positive feedback from clients on our trauma-informed care, high-quality services, and our highly skilled and professional clinical team.
- We do outreach and engagement activities to get the word out.

Healing and Recovery for Survivors: HeRS

Providing face-to-face support for women who have experienced childhood sexual assault.

The HeRS program provides traumaspecialist counselling for adult women in NSW who experienced sexual abuse as a child. This service provides a unique opportunity for women to engage in medium- to long-term counselling for healing and recovery. The program is based in women's health centres across NSW allowing clients not only to attend in a safe space, but also to link into local supports and wraparound services.

143 supported through HeRS

Clients in the program consistently selfreport achieving positive outcomes after the first six sessions. There is consistent demand for the service, however there are challenges related to staffing and referring to regional services. We were grateful to co-locate HeRS with our women's health centre partners across NSW:

- Lismore Women's Health and Resource Centre
- Liverpool Women's Health Centre

Support Across the Continuum

Meeting people where they are and providing support.

We have designed our services with the needs of victim-survivors front and centre:

- Clients know they can reach us 24 hours a day, 7 days a week, 365 days a year.
- Our counsellors are all trauma specialists, with deep skills and experience to create a space that is safe, stabilising and trustworthy.
- We do not triage, but are there for the duration, accompanying people wherever they are in their journey.
- Our team-based model of care means that clients only have to tell their story once, delivering continuity of care even when they speak to different counsellors.
- We prioritise choice and autonomy in every interaction, supporting people to make the choices that are right for them.
- We make space for people to contemplate their experiences and any changes they are considering before they are ready to take action.

We support people by:

- providing a safe, stable space
- assessing a person's level of risk in their current circumstances
- planning for safety
- offering information and strategies for managing trauma responses in the immediate term, while looking towards healing and long-term solutions
- empowering people's autonomy and supporting them to make informed choices
- facilitating referral pathways to specialist services
- supporting people through processes of medical care and forensic examination
- supporting people to navigate police disclosure
- supporting people to navigate the legal system and court
- supporting ongoing healing and recovery.

Professional Services

Supporting those who support others.

There is an inherent and inevitable risk of vicarious trauma and burnout among professionals and first responders who work closely with victim-survivors of violence and abuse and are frequently exposed to others' trauma. Awareness and proactive strategies are needed to help mitigate this impact.

Full Stop Australia offers services and supports to professionals and first responders with dedicated traumaspecialist counsellors who offer:

- tailored, evidence-based programs for managing the risk of vicarious trauma
- dedicated trauma-informed training for first responders and their supervisors
- support to develop a personalised self-care plan and track its usefulness over time
- clinical and non-clinical supervision, debriefing and counselling for frontline professionals.

A highlight of our year has been our sustained partnerships with major organisations to address vicarious trauma and build resilience.

Kirsty's Story

I'm passionate about ending gender-based violence because of a relationship breakdown with my children's father, which led to his fixated hatred. Full Stop Australia provided a safe place I could reach out to when everything was too much. When I couldn't find my way through the darkness, their counsellors shone the light as a beacon to cling on to. The abuse I experienced threatened my freedom, relationship with my children, career, housing, finances and my life. It felt like a war against me by the father of my own children. Each time I spoke up and reached out it was an act of resistance against the abuse. I rebelled against the script the children's father was writing for me. With the help of Full Stop Australia, I got to rewrite my story and change the trajectory of our lives. Now we are in control of our future and it looks bright.

Priority Populations Project

Reaching people at greater risk.

We are committed to working with people and groups who are disproportionally affected by sexual, domestic and family violence. Research shows that First Nations women and girls, people from LGBTQ+ communities, people with disability, and migrant and refugee women and girls are at increased risk. With funding from NSW Health, we started a concerted project to increase our accessibility, support and engagement with these communities.

We take seriously our commitment to reaching these priority populations and creating services that are safe and accessible. As part of our strategy to ensure that all people can access the support they need, we were delighted to welcome Dixie Link-Gordon to our team as the first ever Aunty in Residence in May 2024.

Cultural safety is the foundation of this project, which focuses on responding to systemic barriers, building relationships and engaging with community and identifying ways we can continue to grow and adapt the Sexual Violence Helpline to increase accessibility.

We are working with our team to look deeply at our practice, identify opportunities for training, development and resources required to support this work internally.

We established an Advisory Group for the project to guide the work over the coming year, with a wide range of representation and expertise to support our engagement with priority communities, provide advice on resource development and expand our thinking about embedding this work into the organisation. Many thanks to all our Advisory Group members.

We look forward to engaging in deep conversation through Knowledge Circles with priority communities and working with those groups to co-design resources, identify opportunities to continue to develop our practice and build sustainable relationships.

All our trainers are experienced, tertiary qualified psychologists, social workers, counsellors and educators. Our programs are evidence based and draw on our decades of experience in the sector. As with everything we do, the perspectives of people with lived experience of violence inform our training content and delivery.

Anchored in Consent: Sex and Ethics for Young People

One of our proudest achievements in 2023–24 was developing and delivering a new train-the-trainer program designed for practitioners (including social workers and youth workers) who work with young people aged 13 to 17 who are at risk of, or have engaged in, problematic and harmful sexual behaviour. trainer program to equip practitioners not only to improve the safety of the young people they work with, but also to train others in their sector or location to do so. In an intensive period in March and April 2024, we delivered *Anchored in Consent* to 92 professionals across five local government areas in metro and regional

Aligning with New 'Positive Duty' Reforms

Empowering organisations to lead from the front and fulfil their legislative obligations.

Since the Respect@Work legislation was introduced in December 2022, Australian workplaces have a 'positive duty' to prevent workplace sexual harassment, sex discrimination and other unlawful conduct, and to create safe, respectful, inclusive workplaces.

Changes to the legislation include:

- unambiguously stating that genderbased discrimination in the workplace is illegal
- introducing a duty on employers to take reasonable and proportionate measures to prevent and eliminate discriminatory conduct, such as sexual harassment
- granting power to the Australian Human Rights Commission to monitor and assess compliance with these standards.

We have redesigned our workplace programs in light of positive duty legislation. They span the *Empowering Safe Institutions* training for leaders; training on trauma-informed responses for HR professionals, leaders and general staff; and our all-of-staff programs *Responding with Compassion* and *Ethical Bystander Intervention.* The new legislation has increased demand for our programs and we are pleased to support the change process this reform has created. More organisations, and a wider variety of organisations, are seeking our specialised trainings and consulting.

Workplaces are ideal settings for addressing the drivers of gender-based violence, such as inequality and gender stereotypes, which is why the Respect@ Work legislation is so important. Eradicating these drivers in workplaces has ripple effects across all of society.

Consulting Services

Supporting organisations to create a safe, respectful, inclusive workplace culture.

Through our consultancy services, we work directly with organisations to improve the effectiveness and inclusivity of their strategies and initiatives for preventing gender-based violence. We provide tailored, actionable solutions for creating cultures of safety and respect. Highlights included:

October 2023

We worked with a national investment corporation creating an Integrity Officer role in response to positive-duty requirements, coming up with a series of recommendations for them.

November 2023

We reviewed the external communication strategy for a national tech company, ensuring their in-app safety messaging was person-centred and trauma-informed.

May 2024

We ran four focus groups for a government department seeking to better understand workplace sexual harassment from the perspectives of four particular cohorts, to help tailor a response.

May 2024

We worked with ACON (NSW's leading health organisation for people of diverse sexualities and genders), reviewing the training manual and guide of their sexual, domestic and family violence response program through a trauma-informed lens.

June 2024

We ran a focus group for a university wanting to establish a first-responder network. We talked to key stakeholders, helped them scope the project, and wrote a recommendations report.

June 2024

We began the design phase for a whole-of staff survey into gender-based violence for a large government department.

Sexual Violence Awareness Symposium

Bringing together practitioners, researchers and advocates to end sexual violence in NSW.

In November 2023 we ran our first Sexual Violence Symposium focusing on the importance of integrating prevention, response and recovery in ending sexual violence.

With a keynote address from Yumi Stynes, a presentation from the NSW Police Sex Crimes unit, and expert panels on each of the three themes, we got real about what it will take to end sexual violence in our state.

The event was at capacity with more than 100 attendees and feedback was overwhelmingly positive.

CHANGE MAKING.

Foregrounding lived experience and calling for systemic reform to better support victimsurvivors and dismantle the conditions that drive sexual, domestic and family violence.



Advocacy is the third of our strategic pillars. We are working to improve legal and policy responses to sexual, domestic and family violence, while empowering people with lived experience of violence to be heard in conversations about change.

The National Survivor Advocate Program

Empowering people with lived experience to share their story and advocate for change.

For survivors, sharing their story can be empowering and contribute to recovery and healing. Our National Survivor Advocate Program (NSAP) provides over 700 survivor-advocates of sexual, domestic and family violence across the country with a platform to advocate for change.

We create opportunities for survivors to share their views, experiences and priorities with us and amplify their voices in the advocacy we do as an organisation. We support victimsurvivors to engage with the media and government, supporting them before and after advocacy engagements.

The NSAP Advisory Group comprises 11 NSAP members who guide the operation of the NSAP and provide additional input on Full Stop Australia's advocacy work, supporting us to better centre victimsurvivor perspectives.

Since January 2024 we have also worked with a group of bereaved family members who lost loved ones to domestic and family violence homicide to advocate for better support, preparing a policy document setting out gaps and advocacy asks that has been submitted to the NSW Government. In November 2023, Advisory Group members Harrison James and Samantha Schulte presented 'Centering Lived Experience' at the STOP DV conference alongside Full Stop Australia staff.

In 2023/24 we arranged various opportunities for survivor-advocates to share their lived expertise, including:

- contributing to Fair Agenda's campaign on forensic medical examinations
- providing perspectives to a Sydney Morning Herald article on NSW coercive control legislation
- shaping Full Stop Australia's submission to the Australian Law Reform Commission.

NSAP Media Training Workshops

In October 2023 Full Stop engaged PR company Agent 99 to run two intensive media training workshops for 13 NSAP members, supporting them to think through how they might use their story in media engagement and develop key personal and campaign messages and skills to respond to media opportunities.

The training was incredible, invaluable knowledge and experience gained. Very grateful, thank you!

All survivor-advocates who completed the evaluation survey said they found the media training workshop a safe space to share their story. Survivor-advocates told us they valued the opportunity to receive personalised feedback, and the experience of building camaraderie with a diverse group of survivors.

Our Advocacy Work

Improving legal and systemic responses to sexual, domestic and family violence.

Through our advocacy we aim to:

- ▶ increase the safety of all people experiencing violence
- maximise choice and autonomy for victim-survivors within the legal and justice systems and improve services so they are trauma informed and better meet their needs
- ensure that victim-survivors are supported to heal and recover over the course of their lives, a critical part of breaking cycles of violence
- keep sexual violence in view as a distinct form of violence that occurs within and outside of intimate relationships and comes with additional barriers to reporting and seeking justice.

Improving the safety of victim-survivors by reforming the bail system

After a devastating domestic violence homicide in April 2024 exposed gaps in the way bail laws protected victimsurvivors of domestic and family violence in NSW, Full Stop Australia joined with key sector partners to advise the NSW Government on a series of bail law reforms. We recommended the 'show cause' provisions of the Bail Act be strengthened for people charged with certain offences.

We argued that high-risk perpetrators who have been charged with coercive control or serious sexual and domestic violence offences should be required to 'show cause' before being granted bail. In other words, there should be an additional barrier to them being granted bail.

We also called for victim-survivors' views about their safety to be considered in bail determinations and made the case that all magistrates should receive training on risk associated with perpetrators of sexual, family and domestic violence.

With strong advocacy by Full Stop Australia and our key sector partners, bail reforms that provide improved protection for victim-survivors passed in June 2024.

Our work makes a difference

Full Stop Australia's advocacy was recognised in the final report of the Senate inquiry into affirmative consent, the Commonwealth report into the Crimes Amendment (Strengthening the Criminal Justice Response to Sexual Violence) Bill 2024, the report of the Queensland Parliamentary Committee looking at legislation containing coercive control and affirmative consent amendments, and the report of the Parliamentary Inquiry into Australia's human rights framework.

Sam's Advocacy Journey

speak at the Townsville Regional Candlelight Ceremony and joined with Community Legal Centres Australia on their campaign to lobby the Federal Government to adeguately fund Community Legal Centres across Australia. This led me to the recent opportunity to speak from my lived expertise at Parliament House during a briefing with the Attorney General and the cross bench. The truth is, I didn't dream of a future where I would contribute to the lived expertise legacy of meaningful change to end sexual, domestic and family violence. Lived experience come at a huge personal cost, but I am humbled and grateful that Full Stop Australia legitimises and values the insights of survivors and continues to walk alongside me on this journey.

Full Stop Australia has provided a safe trauma informed space throughout my advocacy journey. Via their support and encouragement I have found the confidence and self belief to use my experiences as a tool of change. Following speaking at the Stop DV Conference in Hobart alongside the Full Stop Australia team I now stand confident in my messaging. I work alongside the charity Broken to Brilliant to deliver lived experience training to QLD Police in response to Recommendation 14 of the Call For Change Report. I have spoken alongside the Honourable Margaret McMurdo AC FAAL and Former Chief Magistrate Diane Fingleton, who was the first woman to be appointed to that position. I have had the sobering honour to be the first victim-survivor to



Our submission to the ALRC Inquiry into Justice Responses to Sexual Violence

In June 2024 we made a submission to the Australian Law Reform Commission with 40 evidence-based recommendations for improving the treatment of victimsurvivors of sexual violence engaging with the justice system.

Informed by more than 50 NSAP members and a review of systems and evidence from around the world, our submission proposed that our justice system was not designed with victim-survivors in mind and largely fails to deliver safety or justice to victims of sexual crimes. Five of our key recommendations were:

Establish specialist sexual violence courts or lists.

Speaking Out to Influence Change

This year we appeared at Senate inquiries into consent law-advocating for an affirmative standard of consent across the country; and human rights legislation-arguing that the rights of victims of crime need to be protected as well as those of the accused.

We facilitated a roundtable discussion for NSW Liquor and Gaming that brought together policymakers, survivoradvocates and sexual violence specialists to discuss the NSW Government's education campaign on drink spiking with a view to improving campaign messaging.

16 Days of Activism Against Gender-On November 25th 2023, Full Stop Based Violence is a United Nations Australia attended the Hope and Heal campaign that has been run annually 'No More Empty Shoes' vigil on Gadigal from 25 November to 10 December Country as a supporter and NSW Vigil since 1991 when the Women's Global Collective member, to mourn the women killed by violence in 2023. Our daily social media and weekly digital newsletter campaign reached



Our Finances

Full Stop Australia continues to deliver on our vision across service delivery, advocacy and education with a modest revenue base. We rely heavily on fundraising and donations to support all elements of our work. This year presented challeneges in fundraising as cost of living pressures impacted donor revenue.

We are deeply thankful to our long term philanthropic partners the PNI Foundation and the Neilson Foundation for their support for our advocacy and service delivery work.

This year we made a significant investment in our organisation's effectiveness through critical IT projects:

- final implementation phase of our Client Management System (CMS), Smarter Soft
- moving to cloud-based storage on SharePoint from an in-house server
- improving our cybersecurity arrangements
- moving to Microsoft 365

These changes, taken together, significantly strengthen our organisational security, capability and flexibility. Our CMS implementation supports our ability to respond effectively to our clients and report on service demand and uptake.

We continue to invest in supporting 1800 FULL STOP from our reserves. A major donation made in FY22 has made this possible and we will be looking to alternative funding sources in the coming vear.

Full Stop has continued to top up government funding for government programs. Addressing this expenditure will be a focus in the coming year.

At the end of FY24 we remain in a financially strong position with close to \$1 million in reserves to support our organisation's sustainability.
